The BIG Picture: What's Happening to Our Economy?

It's been almost twenty years since May 2000, when we started down this 40-year-long path of economic and social revolution (Jupiter conjunct Saturn and both square Uranus, then repeating again in December 2020). We're nearly half-way down that path, and lots of needed changes are occurring. This forty-year revolution is designed to realign our economic and social structures to become sustainable and healthy for everyone, including humans, plants, animals and the Earth. To do that requires LOTS of changes!

What kind of changes are needed?

1. The US, state, and local governments are so far in debt that the infrastructure of the financial system is drowning. Many pension funds are NOT funded appropriately and the people expecting their retirement funds are likely to be outraged when they cannot get those funds.
2. Our current financial system is built on fiat currency (money that's not backed by anything) — which in the entire history of the world, has NEVER been successful — and money that's loaned into existence, i.e. debt. This is not sustainable, especially with the rising interest rates, forcing governments to pay even more for their debts.
3. In 1999 the US debt was \$4.5 trillion. If we couldn't pay off that, how likely is it that we can now pay off more than \$23 trillion in debt? At the moment, we're lucky if the US can maintain paying just the interest. This level of debt is not sustainable with higher interest rates. Nor can it be paid off. This debt is one of the biggest deterrents to a growing economy.
4. The health care system needs a complete overhaul. We should not have health care for profit. In the not too distant past (some of us can still remember!) there was no such thing as health care for profit. This situation has ruined health care in the US, making it not only financially unattainable for many people, but often in many cases, ineffective.
5. Right now there are many more effective treatment methods for very serious illnesses (even cancer), which are not recognized by the AMA and are not paid for by health insurance. Even though those treatments are often far more effective and less costly, insurance and doctors don't utilize them.
6. The pharmaceutical industry is rife with medications which are more harmful than helpful. Yet the FDA allows them to sell their products (even though many are unsafe) and often at very high prices. Over 160,000 people die annually from unsafe prescription drugs prescribed by licensed physicians. These deaths are not from opioid drugs or drug overdoses. These are from prescription drugs with fatal effects.
7. Vaccinations, which we've forever been told are safe and effective, are neither. Major health damage is being done to adults, children, and even babies, via requirements for highly toxic and damaging vaccinations. Most vaccinations and flu shots have over 200 times the amount of aluminum or mercury (both highly toxic to humans) approved for safety. There are serious health consequences for this, for which the pharmaceutical companies are not liable.
8. The education system needs an overhaul. The current system is designed to teach kids facts, but not how to think critically and be able to create solutions to unknown, future challenges. Their world is unlikely to look anything like ours, yet we're not preparing them for that situation. In addition, many kids now are often holistic or non-linear learners in an educational system designed solely for linear learners. It doesn't work for them. Recent tests worldwide showed that US students lag behind in reading, math and science skills, which other countries are far better at teaching.
9. There are many options and suppressed technologies that could be used to replace or supplement fossil fuels and contribute to cleaning up the environment. Plenty of people have been killed for attempting to bring out these new technologies. Until this changes, we cannot create a sustainable Earth.
10. Both parties of the US Congress are controlled by the cabal, people who run the world, but are not elected. Since 2001, both parties have eliminated many of our Constitutional rights, and continue to approve mass surveillance programs, which are unconstitutional. At the moment, the Constitution is still in critical danger of being lost completely.

8. The legal system has two tiers, one for the common person, and one for powerful people, who are not charged with their crimes. Or if they are charged, they receive very light penalties. Often their crimes are massive, far worse than anything the average person in jail has done. This situation convinces people that there really is no justice.
9. Our food, water and air are being contaminated with poisons all the time. Monsanto knew the extremely negative health effects of Round-Up and GMOs in food and yet they were allowed to contaminate our food with them. Now that Round-Up has been proven to cause cancer in a major court case, this may finally get addressed. Chemtrails have contaminated the air with poisons on a regular basis, though there seems to be fewer of them lately. Those poisons affect the soil, water and humans who breathe them.
10. The cabal uses human abuse and trafficking as a means of control Congress and other leaders, both political and corporate. They also use these methods to gain wealth. This is done worldwide to control what happens in the world. It includes stealing children and young people for pedophilia and to become sex slaves. Some are killed to sell their organs. Others are killed for satanic rituals. The cabal uses parties and drugs to lure government officials and major CEOs into this trap.

Once they get photos of the officials with the kids in compromising positions, they blackmail them to do as they're told. Until this is stopped via arrests, our world will be controlled by the cabal. As I write this, there are over 140,000 sealed indictments in all the federal districts for the USA. Many are related to this situation. This situation impacts every aspect of all governments, and all major corporations, plus non-governmental organizations, such as the UN and the IMF, and the World Bank.

11. The Federal Reserve (aka the Fed) is neither federal, nor a reserve. It's a private corporation that is currently in control of the US dollar and the US monetary supply. Since the Federal Reserve was surreptitiously passed in the middle of the night right before Christmas in 1913, the value of the dollar has lost more than 98% of its value. In addition, taxpayers are renting the US dollar, since we pay interest on every dollar *forever!*

This is one of the primary reasons why the US cannot get out of debt. A large percentage of the US debt is owed to the Fed. This is a large transfer of wealth from US taxpayers for an unconstitutional purpose.

The Constitution says that the US dollar will be controlled by the US Treasury. Look at your dollars: they say Federal Reserve Note.

Until the US dollar becomes a US Treasury Note, backed again by gold or a combination of metals, the dollar will continue to decline in value and the US will continue to owe large debts to the Federal Reserve. Congressman [Louis McFadden](#) attacked the Federal Reserve outright in Congress, after which he was shot at, and then poisoned when the first attack failed. He finally died from what appeared to be a heart attack a short while later. The Federal Reserve has never been audited.

Those issues highlight *just a few* of the many changes needed to create a world that's sustainable and healthy for everyone. That's a lot to get done in the next 20 years. While most people are not aware of how and why various laws are made and implemented, the processes involve a corrupt system between the US and international governments, world organizations, and large businesses.

It's so massively corrupt that most people cannot imagine what's really going on. Nor do most people want to know. It's like discovering that your parents are murderers. It's easy to understand why avoidance is a common reaction.

Our Economic and Social Revolution

Our economic and social revolution began with a 20-year cycle (Jupiter conjunct Saturn and both square Uranus), which is relatively rare. The last time we had this cycle was during the US Civil War in the early 1860s. Over 600,000 people died in that war and many more were disabled. It took 20 years to grow a new labor force.

This time, we're having this cycle twice, back to back, in May 2000 and December 2020. That situation hasn't occurred since 1047–1087, (953 years between the beginning of each period!) so it's **extremely rare**.

This set of cycles is the container for major changes to the economy from a bricks and mortar economy to a digital, internet, transportation, and technology economy. This process leads to a new type of economy (air instead of earth) which will last until October 31st, 2219. As you can see, this is a major shift in the economy for a lengthy period of time.

Back in January 1842, we started an "earth" economy, based on agriculture, manufacturing, services, and the financial sector. The "earth" economy officially ends on December 21st, 2020. That's when the new "air" economy officially begins.

By the end of the economic revolutionary process, in December 2040, our economy will be based on information, data, knowledge, transportation, relationships, partnerships, alliances, innovation, and technology. This is well underway now and it will continue to increase.

Our connectivity has increased and we can easily reach new markets without the usual barriers to entry. Plus, there are now different ways to market. We're changing the way we work, and where we work. More people now work from home with periodic office face-time. We're also changing how we live.

Many people may be forced out of corporate jobs to encourage them to start their own businesses. Part of our creativity will be based on our connectivity to each other and the information at our fingertips. Many jobs will be project-based, instead of permanent positions.

These changes will also increase our creativity and bring about needed solutions. Secrets cannot be maintained when everyone is connected. Everything will be revealed. As this occurs, more solutions will also be disclosed.

On December 21st, 2020, the Air Economy officially begins. This time, Jupiter and Saturn will be together in the sign of Aquarius and Uranus will be in the sign of Taurus, exactly the opposite of what we had in 2000. That's when the "air" economy should overtake the bricks and mortar economy. We're getting close to that point and you can already see the results of Black Friday being bigger online than in stores.

Economic Transformation: For a Sustainable Economy

In addition to the economic and social revolution, we're also in the midst of 16 years of economic transformation (Pluto in Capricorn). This indicates "permanent change", not something you can try out and see if you like it, and maybe go back to your old ways if you don't. You can't go back to horses and buggies once you have cars.

That cycle, Pluto in Capricorn, started January 25th, 2008, which was when the financial crisis first began. Pluto then backed itself into Sagittarius for a while, and re-entered the sign of Capricorn on November 26th, 2008. This cycle ends on January 20th, 2024, when Pluto moves into the sign of Aquarius. (Only four more years until then!) Essentially this cycle represents the consolidation of power into the hands of a few, or the creation of a plutocracy. Since that plutocracy doesn't have the best interests of the common man in mind, it's a major issue.

A great deal of wealth was redistributed from middle-class American homeowners to the banksters when the mortgage-banking crisis occurred. Even more has been redistributed by

printing tons of money and devaluing the purchasing power of the dollar. Plenty of money was also fraudulently redistributed via the price fixing of the LIBOR interest rates for years, and other bankster frauds. However, banksters didn't go to jail. (Another example of the two-tier justice system)

Pluto entered Capricorn in 2008 for the first time in 230 years (last there 1762 – 1778). The last time we had this cycle, the USA was not even a country, and we fought the American Revolution. Mercantilism was the order of the day. The colonists could not manufacture anything of their own. They were required to ship materials to England, where everything was produced and then shipped back to the colonists. Mercantilism laid the ground work for the American Revolution.

This time the fraudulent and corrupt practices of governments and businesses are setting the stage for a different type of revolution. We still want freedom and self-determination to be the cornerstone values for America. This time they're more likely to be achieved through technologies, interconnection with others, and disclosure, instead of guns in the streets.

The purpose of this transformation is to create a sustainable economy by transforming the power and structures of the economy. Of course, that suggests some fairly major changes, even radical changes, and the more than 140,000 sealed indictments are likely to be part of this transformation.

Our economy has been primarily focused on what's good for the cabal and the bottom line of business. While the concept of free markets has merit, there are certain cases in which allowing the market to determine the outcome is **not** advisable.

One of those areas relates to the decimation of the planet via the value that the profits of business are more important than the health and well-being of people, animals, plants, and the planet itself. This needs to change significantly in the next 4 years in order to successfully create a sustainable economy.

The Pluto in Capricorn cycle ends on November 19th, 2024, so we're more than half-way through it. Over the next four years, you'll see more changes related to the sustainability of the financial system. With Uranus in Taurus from March 2018 through April 2026, we have even greater emphasis on changing the financial system and currencies.

At some point, Trump is likely to change our currency to a gold-backed US Treasury note (or possibly backed by other metals too), instead of a Federal Reserve dollar. He's also likely to "reorganize" the US debt. Both will likely be forced to change during the next four years.

Default of the US debt, instead of reorganization, is also possible. The US defaulted [quite a long time ago](#) in 1790, 1861, and in 1979 (though that one was claimed to be technical difficulties). It's not only possible for this to occur, it's

likely to be necessary for the US and other countries to default to clean up the debt mess, unless one of the following potentials occurs.

One possibility is that since Trump is confiscating the assets of those involved in human abuse and corruption, it's possible enough assets may be confiscated to pay down the debt. The taxes from repatriated money brought back to the US by large international businesses will also assist in paying down the debt. We'll see if it's enough. In the late 90s the debt level was 4.5 Trillion and no attempt was made to pay it down. Can it ever be paid now that it's \$23 Trillion? MAYBE!

It's possible that the much-rumored humanitarian funds will be released and actually pay down the debt. Although this sounds like a fairy tale, since it's never occurred in the entire history of the world, this could actually happen and give humanity a new start. It's better to hold a vision of this occurring, allowing the possibility, rather than dismissing it.

In addition, the tax structure needs to change in a fairly radical way. Governments normally tax whatever is in short supply, in order to discourage its usage. Back when capitalism started we had very few people (labor shortage) but plentiful natural resources. Back then, no one could even imagine that the natural resources could ever run out.

Today our situation is exactly the opposite. We have plenty of labor, but not enough natural resources. It makes no sense at all to tax labor now. We're stuck in a rut of taxing labor, when it's actually harmful to the economy.

What needs to be taxed, though, is the usage of natural resources. For example, if trees are cut down to print a book, there would be a tax passed onto the reader of that book for the usage of that resource. That would encourage more people to read their books on Kindles or other reading devices.

The tax deduction on federal taxes needs to increase to something like \$30,000 per year, because it now costs about that much for one person to live. That would mean you wouldn't be taxed on earnings of that or less. The new tax bill will get closer to this, but it still has a long ways to go. These are a few ways the financial system needs to change over the next four years.

Uranus in Taurus Now – April 2026 Financial System Changes and Earthquakes!

On March 6th, 2019, Uranus, the radical change-maker, moved into the sign of Taurus, which is associated with banks, financial security, currencies, values — and the value of currencies. Uranus will stay in the sign of Taurus until April 26th, 2026. Until then, we should expect to see changes in the financial system during this period for the US and worldwide.

Potential financial changes over the next six years include:

- The US dollar could become a US Treasury dollar, backed by gold, silver or other assets (i.e. no longer Federal Reserve Notes)
- A global reset could occur, in which each country's currency becomes backed by and valued according to the assets of each country. Unbacked, fiat currency would end.
- A debt reset, reorganization, or default is likely to reorganize the debt of governments. IF this starts with the US, it won't stop there. The debt levels are massive worldwide. Be careful about buying government bonds!
- Crypto currencies could take-off to the point that they become normalized currencies. Your crypto currencies could have a debit card, just like your bank account has one.
- The Federal Reserve could become nationalized, instead of being a private corporation.
- Banking and investment laws could change substantially. Will banks be allowed to continue holding and hedging derivatives? We'll see! My bet is that won't be allowed to continue.
- Some countries in the European Union may pull out of it for financial reasons and go back to using their own currency.
- Some large banks, such as Deutsche Bank or large banks in Italy, may fail or require major support to continue.
- The International Monetary Fund and the World Bank are likely to be transformed or changed substantially.
- Gold and silver are likely to increase in value to very high prices, especially if they are used to back currencies.
- The SWIFT financial transfer system may be replaced to a large extent by a new Chinese transfer system.

Why would we want to return to a gold-backed currency? Since 1971, when Nixon took the US dollar off the gold standard, all countries have basically been paying for goods and services with "Monopoly money" (fiat currency). There was nothing to prevent or slow down the huge increase in the money supply. Money was loaned into existence at a rapid rate. That resulted in the explosion of credit that occurred in the 90s and early 00s, which continued, plus the incredible devaluation of the dollar's purchasing power

An average house in the 1940s was about \$7500. Thirty years later in the 1970s that house was worth about \$21,000 - \$24,000 or about three times as much. After the gold standard was dropped, that same house 30 years later (in the 2000s) was worth about \$300,000 – over ten times as much! That

difference is due to the lack of the gold-backing, allowing the money supply to expand without limits.

These major financial system issues will be addressed in surprising ways now that Uranus is in the sign of Taurus. Bonds are likely to encounter surprising and scary scenarios.

Your money will be safer in crypto currencies or gold than in government bonds while Uranus is in Taurus.

Remember: ALL G7 countries have too much debt and it cannot be repaid. If you're invested in bonds related to any of those countries, including the US and Canada, you could LOSE a LOT or ALL of your investment when a Jubilee Year is finally declared and all bond debts are simply wiped out and never paid. (IF this occurs). This is a distinct possibility during the time that Uranus is in Taurus.

Although it's best to hope that the humanitarian funds will pay off the sovereign debts, you still might want a safer way to invest your money than US or other G7 country bonds.

That being said, a number of these changes could wait until January 2020 or later, when Saturn finally meets up with Pluto in Capricorn and they start transforming all dysfunctional structures. Be aware of this situation and keep it in mind with your investments.

Uranus in Taurus also represents **unexpected earth changes**, earthquakes, volcanoes, cracks in the earth, sinkholes and more. We've seen plenty of that already! This is likely to continue through April 2026.

Lastly, Taurus represents values in general. Uranus in Taurus represents fairly radical or unexpected changes in values. Uranus is associated with **independence and freedom**, so these values are going to continue to increase while it's in this sign. You can see this occurring already, with so many countries having major protests, and protests that are related to the freedom of the people. It's hard to imagine that any dictatorships will last beyond this cycle.

What's Different for the 2020 Economy?

Jupiter in Capricorn: New Growth Industries!

On December 2nd, Jupiter moved from Sagittarius, where it's strong and competent (rulership), into the sign of Capricorn, where it's weak and incompetent (fall). It will stay in this new sign until Dec 19th, 2020. This doesn't bode well in general for growth, expansion, and abundance. However, some new cycles for Jupiter could indicate that some growth is maintained during 2020.

First of all, Jupiter isn't happy in an earth sign (Taurus, Virgo, Capricorn), as all that practicality tends to dampen Jupiter's enthusiasm with a bunch of down-to-earth questions.

On the other hand, Jupiter will immediately be in a positive and excellent cycle (trine) with the planet of Uranus when it moves into Capricorn on December 2nd. This suggests unexpected growth, and during the holidays, this could mean higher retail sales than normal through mid-January.

Then in mid-February Jupiter begins to catch up with Pluto in Capricorn. That's the beginning of a new power cycle. It will peak the first of three times late on April 4th in the US. This cycle stays in range through December 17th, 2020. It peaks for the last time on November 12th, 2020, just after the US Election.

The new power getting started has to have integrity (Capricorn) or it won't be allowed to maintain power. It looks like a lot of political changes could occur under that cycle.

So even though this is a tough sign for growth, with these cycles, growth could be maintained by going in a new direction, one that's sustainable and which has integrity.

The following industries will tend to grow while Jupiter is in Capricorn. This list is not exhaustive, but will give you a broad idea of which type of industries will expand.

Capricorn Industries:

- Government services and organizations
- Services and products for the elderly
- Minerals and mining companies; diamond companies
- Museums
- Masonry and lumber industries
- Professional services companies; professional organizers
- Political campaign offices
- Time industries: watches, clocks, calendars

Taurus Industries:

- Banks, credit unions, savings and loans Investment firms
- Luxury items, such as jewelry, furs
- Designer name products
- Sensuous & beauty products, such as cosmetics, aromatherapy, perfumes, special soaps, candles
- Comfort products
- Massage, beauty salons, and other body care services
- Florists and flower industry
- Currency exchange and coins

Virgo Industries:

- Computer and software industries, including repair
- System analyst companies

- Pets, pet care and veterinarian industries
- Health care industry; diet & nutritional supplements
- Housekeeping and custodial companies
- Data processing companies
- Scientific engineering & equipment companies; technical companies
- Clothing industry and tailors
- Dry cleaning companies

Note that while Saturn remains in Capricorn (until March 22nd and then between July 2nd and December 16th), the growth of the earth sign industries (shown above) can be somewhat reduced from what it would have been without this placement. However, occasionally it also suggests a shortage of supplies from those industries, creating higher prices.

The following industries have an opportunity for growth, usually not as much as the above industries, but still positive:

Scorpio Industries

- Insurance industry
- Funeral industry
- Tax accountants and representatives
- Waste management industry
- Environmental resource renewal companies
- Nuclear fuel and power plant industries
- Psychological and sex therapists; mental health clinics
- Energetic and shamanic healing
- Prostitution, mafia, underworld companies

Pisces Industries:

- Overseas shipping and maritime industries
- Oil and natural gas industries
- Pharmaceutical industry; alcoholic beverages
- Photography, film, and movie industry
- Hospitals
- Spiritual or inspirational companies
- Drugs (illegal)

Jupiter, Saturn, and Pluto in Capricorn

As 2020 starts, Saturn is very close to Pluto and they meet up exactly on January 12th, just two days after the Lunar Eclipse on January 10th. The Saturn – Pluto conjunction (in the same place) begins a long, rebuilding process.

The last time this cycle occurred in Capricorn was on December 19th, 1284, a little more than 735 years ago! This lets us know how RARE and of enormous importance this cycle really is. The structural transformation of governments, corporations, and NGOs is about to really start.

At the time of the conjunction on January 12th, the Sun, Ceres, Saturn, Pluto, and Mercury are all within one degree of each

other. This is a strong indication that taking care of each other is an important aspect of the changes we'll see as we rebuild. It also suggests that mental integrity is important to what we achieve. We need to use logical thinking and discernment, and avoid being conned by nefarious, untrue, overblown stories.

As the conjunction starts, we'll have completed the breakdown phase of structures, processes, organizations, and governments that are unsustainable or out of integrity. Then comes the transformation associated with rebuilding new processes, structures, changing companies, governments and organizations of all types.

One of the major issues associated with governments, and non-governmental organizations (NGOs), such as the UN, the World Trade Organization, World Bank, International Monetary Fund, and many others is the immense amount of corruption that's infiltrated them. This has also occurred in churches, the medical, legal, and education systems, including higher education. It doesn't seem to matter whether the organization is governmental, non-governmental, religious, or corporate. The level of corruption is incredibly large and entrenched.

Since we're starting with such a major task, it makes sense that this process will take many years to transform and rebuild. Expect this process to continue until we get to the cycle of Saturn opposite Pluto in late July 2036. Considering the task, this is actually quite fast.

Saturn will tiptoe into the sign of Aquarius in 2020 and then stay from mid-December 2020 through early March 2023. Plus Pluto will enter the sign of Aquarius in 2024. These cycles suggest higher consciousness ideas and even "miraculous" technologies will begin to take hold and be implemented, making the process to rebuild easier and more effective. Solutions are always at a higher level than the problem.

Fortunately, this process is likely to include new technologies that have been suppressed or withheld from us for years.

The above Navy patents show that much of the science fiction world we've seen on television and in the movies is actually in existence. It looks like there's a plan to disclose this now through the patent system, and the soon-to-be Space Force (currently Space Command).

Of course, there are other technologies that exist, which can cure any and all diseases and illnesses, and even regrow organs, including missing limbs: [Med Beds!](#) When Gregg Braden and Dr Bruce Lipton spoke to the United Nations in 2016, the UN told them that they knew how to cure all illnesses and diseases! That was over three years ago, and we still haven't heard a peep about this in mainstream news.

Why would we start to see these technologies released soon and even now through the patent office? This is where Jupiter and Uranus come into play. Both of these planets are associated with freedom, liberty and independence. How is that related to these new technologies? The new technologies will bring about an unprecedented level of freedom and independence in energy, medicine, and even prosperity.

Jupiter's Contribution

Jupiter was in its home sign of Sagittarius during 2019 until early December, pushing freedom and new, higher goals. Now it's in Capricorn, and during December–mid-January it's trine to Uranus, a combination that strongly supports freedom and independence, along with unexpected growth. Because this cycle was part of the Winter Solstice energies, these energies will impact us through the first quarter of 2020.

Before that's over, Jupiter comes in range of a conjunction to Pluto in mid-February and stays in range through the rest of 2020. They meet three times, in April, June, and November. That cycle hasn't occurred in Capricorn since 1771. It's associated with creating freedom and independence within governments and other organizations.

At the time this cycle last occurred, there were no democratically elected governments. In fact, only the Native American councils had a voting process that was used to make decisions for their tribes. It was the guidance from the Native Americans that eventually led to the establishment of our Congress and the American Constitution.

When cycles repeat over time, they spiral up to the next level. In the USA, this spiraling up includes reclaiming the Constitution, which has been greatly eroded over the last twenty years, and even before then.

For other countries, this cycle indicates a new level of freedom is being pursued by their citizens. Hong Kong, France, the UK, Chile, Venezuela, Iraq, Iran, Italy, Spain, Greece, and many more countries are in this process. You will witness the ending of dictatorships as this process restarts again.

During 2020, there will be times when Jupiter, Saturn, and Pluto are all fairly close together in late Capricorn. This suggests that the restart of governments that embrace

freedom will also embrace integrity and sustainability within governments.

Keep in mind that it took another 5.5 years for the Declaration of Independence to be signed after the start of this cycle in February 1771. It takes time for the process to unfold. Just know it's happening, and do what you can to ensure it stays on track toward more freedom and integrity.

Saturn in Capricorn: Industries that Consolidate

Saturn in Capricorn is like the no-nonsense manager who expects a lot from you, and then provides you long-term rewards for your good performance. He wants you to meet your goals, no excuses! If you don't handle your obligations well, then you reap the consequences. Saturn in Capricorn is a tough taskmaster, but also fair. You reap what you sow.

While Saturn is in Capricorn, certain industries will be consolidated and limited. **Here's a list of the industries that can expect to consolidate until March 21st, 2020.** These industries will have a short reprieve **until July 1st, when Saturn moves back into Capricorn and stays until December 16th, 2020.** After that it moves into Aquarius.

Jupiter in Capricorn will assist the Capricorn industries, so they will get growth, but not as much as they would have gotten without Saturn in the same sign.

These are the industries that will continue to consolidate while Saturn is in Capricorn on and off throughout 2020.

Saturn Tiptoes into Aquarius in 2020

Late on March 21st, 2020, the day after the Spring Equinox, Saturn slips into Aquarius for an early preview of what's ahead. It doesn't stay there long, as on July 1st Saturn moves back into Capricorn, where it will play footsies with Pluto and Jupiter until December 16th /17th, 2020, when it moves back into Aquarius to stay until March 7th, 2023.

Saturn is the planet which represents your responsibilities, duties and obligations. It also represents all types of structures, buildings, processes, all types of organizations, management or those who are in control. Saturn was the original ruler of Aquarius and still co-rules the sign, along with Uranus. So Saturn in Aquarius is strong and effective.

Aquarius is a sign that's associated with higher consciousness. It's an air sign, mental in nature. The "water bearer" symbol is actually pouring higher consciousness out of the jug, not water. The significance of this sign is that new, advanced ideas are brought into the mainstream. This often suggests unexpected or revolutionary changes, such as when cars replaced horses and buggies.

The last time we had Saturn in Aquarius was February 7th, 1991 through January 28th, 1994 (with a minor incursion into Pisces for a few months in May and June 1993). It takes Saturn about 29 years to go through the entire zodiac. This is why you often see trends returning from 30 years ago, as Saturn returns to that same sign.

Saturn in Aquarius is related to creating structures based on higher consciousness. What those structures are depends on what's already there and what there is to work with. Each time this cycle occurs, it spirals up to the next level of structures, with the next level of higher consciousness.

So think back to 1991–early 1994. A lot of what we know now was not known then. The Secret Space Program was unheard of back then. Very little was known about the cabal and how they ruled the world. Coast to Coast AM had a lot of good information about many secrets, including UFOs.

However, the overall consciousness then was much more in the dark than it is currently. In general, we didn't know that the news included fake propaganda (fake science studies, etc). Most people trusted mainstream media then.

We didn't know that both political parties were controlled by the cabal, and for the most part, we didn't really know the cabal existed. We had no clue how much corruption was in place, though we knew some of it occurred. There was no knowledge of the sex trafficking, the pedophilia, and satanic rituals that kill children. We didn't realize what the CIA was doing around the world to disrupt and destroy other nations' choices. False flags were occasionally rumored, but generally were unidentified.

Since then, a lot of disclosure has happened, including the patents for the Navy of those science fiction technologies! (See the previous page for links to that info.) UFOs seem to be hiding in plain sight, as the number of sightings has increased tremendously. The 9/11 destruction has been proven to NOT be related to the stories we were told.

We know the media makes up stories, and plenty of them. We know the pharmaceutical industry kills over 160,000 people per year in the US with unsafe, prescription drugs (*not including opioids*). We see the education system failing to teach children the basics, let alone critical thinking skills. We see a two-tier judicial system, one which robs the middle class of billions of dollars, and never penalizes the bankers or corrupt politicians. See the difference that the last 29 years has made?

What kind of higher consciousness structures can we expect Saturn in Aquarius to initiate this time? In terms of organizations, and even companies, the main theme should contain group consciousness focused on creating solutions to challenges with higher-level thinking (and higher vibrations).

Physics could become the order of the day. Healing medicine could switch from chemistry to frequencies. This is already getting started. Check out <https://www.therasha.com/>

New technologies are more likely to be released, especially with the new structures being created with the Space Command, and soon to become Space Force. Suppressed

technologies will start being released, now that we know they exist, and frequently have existed for many decades.

It's unlikely we'll see all this next year in the few months that Saturn will be in Aquarius. Most of this will show up in 2021 through 2023. Yet it's worth noticing what starts showing up in April – June of 2020, as a prelude to what's ahead.

Inflation in 2020?

While Jupiter is in Capricorn during 2020, it will sextile Neptune, the planet associated with interest rates and inflation. This occurs at the beginning of February and lasts through mid-March. This comes back into play at the beginning of July and lasts through the beginning of November.

This cycle (Jupiter sextile Neptune) shows some inflation occurring, especially since Saturn is not in a cycle with Neptune at the same time. However, since this is a weak cycle, especially with Jupiter in Capricorn (slow growth), the inflation should not be excessive or enough to cause serious issues. It might be enough that the Fed will feel comfortable raising rates again. We'll see how they play it.

Jupiter Conjunct Saturn in Aquarius! A New Economy Begins! Part II of the Economic and Social Revolution

Jupiter will move into the sign of Aquarius on December 19th, 2020 and he immediately meets up with (conjuncts) Saturn on December 21st, 2020. This occurs on the same day as the Winter Solstice – always a *big heads up!*

At the time this occurs, it will be the second time (consecutively) Jupiter conjunct Saturn will be square Uranus. This is the cycle that started the economic and social revolution in May 2000. The last time this cycle occurred, it started the last twenty years of an earth economy. The earth economy (agriculture, manufacturing, services and financial products) started in January 1842 and it lasts until the next Jupiter-Saturn conjunction occurs on December 21, 2020.

When this next conjunction occurs, it will be the beginning of a new economy, known as an air economy in astrology. This type of economy is based on:

- data, information and fast transportation (Gemini)
- relationships, marketing alliances, partnerships, and a well-functioning, judicial system (Libra)
- new technologies, innovations, and higher consciousness creations (Aquarius)

It's not that we'll stop growing food or manufacturing items. We'll always continue to have services and financial products too. The difference is that those areas will not be the primary

growth areas of the economy. They'll take more of a back seat or they'll be assisted by the new ways we do business via the internet and social media.

Notice though that we've already started down this path in the last twenty years and it will continue to increase. The Air economy will last until October 31st, 2219 and during that time we'll see the evolution of this new economy.

During the coming twenty years though, while this cycle unfolds again, we'll see a lot of revolutionary changes to the economy and society. This is one of the several, RARE cycles that are converging now, signaling an unprecedented time in history!

A Year of Rethinking: Get New Starts Going EARLY!

The year of 2020 is filled with plenty of personal planet retrogrades. Every year has three periods when Mercury is retrograde. However, 2020 also has Venus retrograde for six weeks and Mars retrograde for ten weeks.

These retrogrades start with Venus moving backwards beginning May 13th. It lasts through June 25th. However, Mercury retrograde begins June 18th and lasts through July 12th. So there's two months with a LOT of rethinking, especially financial and relationship rethinking.

Late July and most of August are extremely challenging. I felt anxious just *looking* at those cycles. It's probably related to the Election. However, you really don't want to start a new company, introduce new products or start new projects under such stressful cycles.

Then beginning September 9th, Mars retrograde begins, when it's impossible for new starts to get going. That's because this cycle is focused on rethinking where you want to go for the next two years. This lasts until November 13th, and during that time, Mercury is retrograde October 13th–November 3rd — Election Day! We'll see how that stopped Mercury plays out for the election. Recounts? Or re-election of Trump?

The end of November through the middle of December we have eclipses – ROUGH on new starts. Get the picture? **Get your important new starts done now through early April.** After that it's slim pickings for any good dates for new starts. **PAY ATTENTION to this!**

Quarterly Overview: January – March 2020

January: An Unprecedented Year Begins! End of the Road? Or a New One Begins?

Welcome to an unprecedented year! It may be hundreds of thousands of years, even a million years or more, before we'll have FIVE RARE cycles *that haven't occurred in hundreds of years* converging in one year. This year—2020—is that year!

What does this suggest? That you can expect unprecedented events to occur! Yes, even “miracles” can occur. Actions you never expected are much more likely to happen in 2020.

Are you ready for new technologies to be released? Could it be that we already have military bases on Mars, the Moon and other places in space? Could all the sovereign debts get cleared up? Could the cabal be arrested and brought to justice? As “crazy” as some of these ideas sound, all are possible to start in this year. These five rare cycles are that unparalleled and extraordinary.

What can slow down these unprecedented events? People who don't believe it's possible for these changes to occur. Everything that occurs is based on the consciousness of the people and the cycles that are occurring. For faster changes, it's important to be open to the possibility that they'll happen.

Justice Is Coming!

On January 2nd we get the first major cycle of the year, (when we're back to work) and it's an important one. Mercury conjuncts Jupiter in Capricorn on that day, in effect announcing justice is coming! (Jupiter is associated with the legal system, the judiciary, and Congress. Mercury is associated with announcements and communications in general.)

This is likely to be the theme for the entire year ahead. So even though this cycle peaks on January 2nd and stays in range through January 7th, this process is just beginning. It will take until January 10, 2021 for that entire cycle to complete (when Mercury completes the cycle at its next conjunction). With Jupiter in Capricorn, the justice is likely to be sobering.

Mercury doesn't stop with announcing justice is coming. He then moves on to join with the Sun (President), Saturn and Pluto, as they meet together on January 10th – 12th. This could suggest that the mainstream media is about to encounter consequences for lying repeatedly and knowingly. Or perhaps

it suggests that the mainstream media will suddenly start reporting the truth? We'll see which way they handle this.

Just days before the major, January events (a traumatic eclipse, plus Saturn conjunct Pluto), another set of cycles suggests idealistic goals or an important vision are being discussed (Sun and Mercury sextile Neptune). With the Sun and Mercury in Capricorn though, those ideals or visions have practical and strategic importance. It's not just pie in the sky. These cycles peak on January 7th and 8th and they're in range January 5th – 9th.

With these cycles in mind, I want to remind you of a very important background to all of what you'll see this year. [Kryon](#) has told us repeatedly that the Earth and the entire solar system are travelling through a part of the galaxy where humans have never been before. This part of the galaxy has very high frequencies that *humans have not been exposed to before*. The impact of these frequencies in the long-run is that they'll increase consciousness on Earth.

Why am I reminding you of this? Kryon has repeatedly said that due to these higher energies, there's now MORE LIGHT on Earth *than at any time previously in the entire history of the Earth*. More light means that we're seeing not just more, but all of what the dark has been doing behind our backs. In fact, it's impossible to hide wrong-doing any more! It's all coming out.

Keep this in mind as the year progresses. Things are NOT getting worse as this wrong-doing is revealed. Instead our world is getting better, as the criminals are being exposed and made accountable for their actions. Think no one is going to jail? Think again! Jupiter is in Capricorn and there are legal consequences to those actions while Jupiter, Saturn and Pluto are all there together.

In the business world, Mercury conjunct Jupiter in Capricorn can be a good time to promote products related to the elderly, governments, new platforms, processes, and structures. With a traumatic eclipse and a rough set of energies that haven't occurred in 735 years happening at the same time, this cycle is not as likely to produce the results it normally would. Read on to understand the additional challenges.

Mental Clarity on January 9th - 10th

On January 9th–10th we get a cycle that's associated with mental clarity (Sun conjunct Mercury within 17 minutes of exact). This cycle often brings attention to information you've been missing or misunderstanding. This window occurs for a very short time, and begins at 10:36 PM Eastern / 7:36 PM Pacific time on January 9th. It lasts until 9:58 PM Pacific / 6:58 PM Eastern on January 10th.

Since this cycle includes sleep time in all US time zones, you may actually dream the information you've been missing or misunderstanding. However, it could also be brought to your attention by another person, an assistant, or someone who handles a lot of details. You could also be shown this information via news, articles, books, or social media. This is a good time to pay attention to details!

The Lunar Eclipse also occurs during this cycle, highlighting the fact that an eclipse event may be triggered via news or while on a trip.

Lunar Eclipse on January 10th: Traumatic Transformation!

We start this year with an eclipse in range that's associated with the sudden ending of associations or a relationship that can lead to traumatic transformation. This actually seems like it could be a metaphor for the year ahead. However that depends on your view of the changes the Universe brings.

Five RARE cycles, ones that haven't occurred in hundreds of years, converge in 2020. The first one peaks two days after this eclipse (Saturn conjunct Pluto in Capricorn) and it's a cycle that hasn't occurred in 735 years.

Could some of those sudden endings of associations leading to traumatic transformations be related to arrests? Saturn and Pluto meeting in the sign of Capricorn represent the Universal cops and detectives. This is the year you're likely to see the past leaders and officials of the FBI, the Department of Justice, CIA, the State Department, and even Congressional leaders arrested for treason and sedition.

This eclipse on January 10th occurs at 2:22 PM Eastern time / 11:22 AM Pacific time. The energies are uncanny: five planets (Sun, Mercury, Ceres, Saturn and Pluto) all within 2 degrees 42 minutes of each other with the Moon directly opposite them at 20 degrees Cancer. This is a VERY tight and intense configuration. What does it mean?

Could it suggest that President Trump will be removed from office? Not likely, since the Sun, representing the President, is with Saturn and Pluto, suggesting he's supported by the law. The fact that there was no evidence of wrong-doing on his part related to the Ukraine case reinforces what astrology shows. That leaves the unscrupulous, but hidden, criminal activities of the FBI, Department of Justice, CIA, State Department and foreign intelligence agencies to be addressed.

The 465-page report from the Inspector General related to the FISA abuse lists quite a lot of criminal activities carried out by the FBI and Department of Justice. Although we don't yet have any details, we know there's a criminal investigation by John Durham into actions carried out by the CIA, FBI, Department of

Justice, other US intelligence agencies, and multiple, foreign intelligence agencies.

As noted in the article above this one, Mercury is very close to the Sun during this eclipse (within 6 minutes of exact!). Whatever is occurring, news, the media, or transportation seems to play an important part. Another clue to what's occurring is that Uranus starts moving forward on the same day (January 10th), suggesting that we're ready for changes. See the next article for details related to this.

In this eclipse chart, there's also an indication of justice for past actions (Jupiter conjunct the South Node). We'll see how this plays out. The other noteworthy cycle with this eclipse (Moon sesquiquadrate Mars) suggests outrage and anger from the public. This is what I would expect to see from people who are not aware of the criminal activities of the Deep State.

Eclipse events can occur up to 30 days prior to or 30 days past the actual eclipse. They can even occur beyond that range, but most occur within that 60-day window.

If you have personal planets close to 20 degrees Cancer or Capricorn, you may personally experience a sudden loss of associations or the loss of a relationship that leads to a traumatic transformation.

The Christmas eclipse at 4 degrees 7 minutes of Capricorn is still in range until January 25th. It also has the same primary meaning, but it had some protection with it (Sun conjunct Jupiter). If you have planets near 4 degrees Capricorn or Cancer, that eclipse could impact you the same way.

Uranus Direct: Change Moves Forward!

Uranus is the planet that represents unexpected changes, new technologies, advanced ideas, heretics and radicals. It's significant that it moves forward on the same day as the Lunar Eclipse and two days prior to the peak of the cycle associated with structural transformation (Saturn conjunct Pluto). We're ready for major changes!

Uranus started moving backwards (retrograde) on August 11, 2019. Since then you may have been developing, or researching how to implement, new technologies or other major changes. The signal of Uranus moving forward let's us know that it's time to move forward with changes again.

It may still take some time to get them started, as Uranus is very slow and sitting at the same degree until February 8th. On the other hand, this is also signaling that we're ready for the structural transformations that begin on January 12th.

Structural Transformation Begins!

The cycle associated with structural transformation (Saturn conjunct Pluto in Capricorn) has been in range since late January 2019. During that time we've witnessed numerous situations, personal and global, which were either unsustainable or out of integrity. As this cycle peaks on January 12th for the first time in 735 years, a number of these issues are moving forward to change and rebuild.

A good example is the UK's departure from the European Union (EU). Now that the latest election there was a smashing success for Prime Minister Boris Johnson, the UK will be leaving the EU, with or without a deal.

That's a major, structural transformation for the EU, since the UK was the #2 contributor to the EU budget, and the #1 trade partner for Germany. It will also provide the UK with sovereignty and freedom to run its own country. The EU's heavy-handed control of the countries will face other severe challenges from other countries as well.

As this cycle peaks in Washington DC, Jupiter in Capricorn is at the top of the chart, emphasizing justice again, or possibly international situations. The Sun, Ceres (dwarf planet associated with nurturing), Saturn, Pluto and Mercury are all together within 1 degree 16 minutes of each other (yes all five planets within 1 degree 16 minutes). This is an incredibly significant and close line-up!

Notice that Mercury has been front and center since January 2nd and it continues to be part of the major action with this big group. Since Mercury seems to be part of the structural transformation, it may be that the media is being investigated for knowingly lying to audiences. Or perhaps the media have changed their tune and started telling the truth? Mercury in Capricorn is much more of a stickler for accuracy.

Ceres is also there, a dwarf planet associated with nurturing others. However, in the sign of Capricorn, this nurturing tendency is directed more toward governments, or other large organizations, structures and processes. Ceres is a slow planet. It takes about 23 years for it to go through the zodiac. That she would be in the exact degree as Saturn and Pluto when they meet is amazing.

The Sun, which always represents the leader of the country, and leaders in general, is also very tightly conjunct Saturn and Pluto (less than one degree). This is a line-up for structural transformation to support law, order, justice, and renewing the country, led by a powerful (Pluto), strategic and effective (Saturn) leader of the country.

Either the media will join in this transformation via truth telling or they'll be transformed in ways they've never been before.

What could happen to the media for knowingly lying to the public about Trump and conspiring with the criminal factions of the FBI, CIA and Department of Justice to overthrow an elected President? That's known as sedition and there are serious laws and penalties for that. It's also possible that the FCC could deny their broadcasting licenses. This has been discussed and considering these cycles, that's a likely scenario unless they start telling the truth.

As Saturn conjuncts Pluto in Capricorn, the structural transformation of governments, large organizations and major corporations is underway. We're now starting the rebuilding phase of the process for the next 17 years until July 27th, 2036.

The entire cycle of Saturn-Pluto takes until February 1st, 2054 to complete, about 34 years from now. During that time, you should see the UK depart the European Union (EU), and the EU transform itself due to other countries wanting to depart. The USA will regain its Constitution over the next five years. We'll see how China changes.

Hong Kong and other countries will continue to fight for and gain their freedom (Jupiter conjunct Pluto). In fact freedom is also one of the major energies of the moment. These issues join together this year.

A Word About Conjunctions

This month we have at least 5–6 planets together (conjunct) in the sign of Capricorn, plus the South Node. When planets are bunched up like this, there are fewer aspects or cycles than normal. However, the energies are more intense than usual. That's because they're all vying for expression in the same arena, in this case in the sign of Capricorn.

It's like watching a basketball game and everyone is on one end of the court trying to get the ball in one hoop, while the rest of the court is empty. All the action is one spot and it takes time for the players to spread out again. This month is like that part of the game, with a huge focus on governments, justice, and Constitutions – worldwide, not just in the USA.

Unexpected Money or Love? Followed by Surprising News?

Beginning January 12th (yes in the midst of structural transformation!) a cycle comes in range that's associated with unexpected money or love (Venus sextile Uranus). Compared to all the other action, this cycle may go unnoticed by you because all the attention is likely to be elsewhere. However, for business purposes, this cycle is helpful in generating some revenue. This cycle peaks on January 15th and it stays in range through January 17th.

On January 13th, another cycle comes in range that's related to surprising news (Mercury square Uranus). Typically the news that comes out with this cycle is challenging and unexpected. These energies are also rough for communications in general, web site, social media, internet availability, etc. They are also associated with accidents. Be careful driving during this period.

This cycle peaks on January 18th and it stays in range through January 21st. Just as this cycle ends, another one associated with leaders taking unexpected actions, or departing in surprising ways, comes in range (Sun square Uranus). That one peaks on January 23rd and stays in range through January 29th. It's best to remain non-judgmental during this period!

If you can do that, another cycle will bring in more money (Venus sextile Jupiter). That cycle comes in range January 19th – 25th and it peaks early on January 23rd. Venus is in her best sign at this time, making it easier to make good money. Do your best to take advantage of this cycle.

New Moon on January 24th: Radical and Deceptive Actions?

What's getting started at the New Moon on January 24th are unexpected actions by leaders and the public (Sun and Moon conjunct in Aquarius and both square Uranus). This is the New Moon in Aquarius when, higher consciousness and freedom are attempting to make some progress. However, it appears there are some challenges in trying to accomplish that (Sun and Moon square to the ruler of Aquarius).

Typically this appears as erratic or unexpected actions by leaders. Some leaders or celebrities may leave their positions suddenly or die. With so many planets still in Capricorn, it could also be that some past leaders (South Node in Capricorn) are being arrested.

At this time, there appear to be deceptive actions taking place, especially related to money (Venus conjunct Neptune and both square Mars). This might indicate issues in the stock market, especially if a major corporation is revealed to have faked their numbers. Or it might be a reaction of the cabal to some of their members being arrested, then selling to drop the markets. It might also be related to issues with sports or sport teams.

On a personal note the above cycles (Venus conjunct Neptune and square Mars) can also suggest that you don't know how to get what you want. You may have a vision you're attempting to fund, yet you cannot see the path to get from where you are to where you want to be. This is the lesson of faith and trusting the Universe.

Your job, should you choose to accept it, is to know what you want to accomplish and keep your eye on that. The Universe's job is to show you how to get there. You need to follow the

bread crumbs it's putting before you, knowing it has a plan in mind to assist you. Just keep following the next step. That's all you may know at any time, just the next step. Your job is to know the *what*. The Universe's job is to know the *how*. Keep going by trusting yourself and the Universe!

The cycle related to not knowing how to get what you want (Venus square Mars) comes in range on January 13th and peaks January 26th, two days after this New Moon.

The cycle related to deceptive actions (Mars square Neptune) can also relate to not having enough energy, and possibly getting sick. That cycle comes in range on January 17th and it peaks on January 28th. Both those cycles are in range through February 8th.

The combination of Venus conjunct Neptune square Mars often suggests a LOSS of funds or disappointment in relationships, especially romantic ones. This can certainly occur under these cycles. However, two other cycles are mediating the impact of this situation (Mercury sextile Mars and Venus sextile Jupiter). So whatever deceptive actions are being taken, others are there to help offset them.

To be on the safe side though, I recommend that you not loan money or invest under these cycles. You could easily lose your money. As mentioned previously, the stock markets could also drop. If so, the other cycles will help support the markets, so it's temporary and probably not severe.

The cycle of Mercury sextile Mars is often related to debates or verbal warfare. If the Senate is handling the impeachment, these energies are appropriate for lawyers to attack or defend others. This cycle is in range between January 22nd – 27th and it peaks on January 25th.

Some parts of Congress also appear to be involved in deceptive actions at this time (Venus ruling the 11th house). This might be related to funding bills or foreign aid. Another part of Congress appears to be involved in doing judicial work (Venus sextile Jupiter). We'll see what gets done.

February: Mercury Retrograde Begins February 16th

As we start February, this is a time when you can develop long-term relationships with people in power or authority (Venus sextile Pluto followed by Venus sextile Saturn). These cycles are also associated with good, steady revenue, and those relationships mentioned above may be the reason for that revenue. If you have an opportunity to create a marketing alliance with another professional or a company, this is a good time to formalize that.

These cycles are also related to passionate, long-term love relationships. The passion may calm down as the long-term nature of the relationship continues. However, it'll still be there.

The passionate and powerful relationship cycle (Venus sextile Pluto) comes into range on January 30th. It peaks on February 2nd and stays in range through February 4th. The long-term relationship and steady revenue cycle comes in range late on January 31st. It peaks on February 3rd and stays in range through February 6th.

Blue Communications Begins on February 2nd

Blue Communications is the period right before Mercury retrograde begins when Mercury is travelling through the area it's going to retrace. This time the period begins on February 2nd and lasts through February 15th. Mercury retrograde begins the next day on February 16th.

Once the Blue Communications period begins, you cannot outrun Mercury retrograde. You're more likely to make mistakes during this time, and then discover them during Mercury retrograde. By the time you find the error(s), it's typically a "crisis" that must be fixed immediately.

For this reason, the best advice for this period is to SLOW DOWN, so you can double-check all details for accuracy and clarity. If you do this, you'll have far fewer of these issues to handle and that means you'll have time to catch-up.

Actually, catching-up is one of the primary purposes that the Universe has in mind for Mercury retrograde. So it behooves you to catch those mistakes *before they get out the door*, even with emails and texts.

The other precautions to take at this time are to back-up all your computer and phone systems, plus ensure your car is working correctly. If your car is making funny noises, this is the time to get it fixed before the car is more likely to breakdown during Mercury retrograde.

New Ideas? New Technologies?

Beginning February 3rd, new ideas, new technologies, or surprising news are available. This is a short cycle (Mercury sextile Uranus), that's also helpful for web sites, launching announcements online, and social media. It peaks early on February 5th and stays in range through February 7th.

At the time of this cycle, a more challenging cycle is in play (Ceres square Uranus) and this one helps to mediate it. The challenge of that cycle is that nurturing time may be disrupted. Perhaps someone is moving their home or office? This cycle will provide new ideas to deal with the disruption, so it's more

manageable. Mercury is also quintile Mars, suggesting there are good skills available to probe or persuade others now.

Full Moon on February 8th / 9th: Love Relationships Beginning? Money is Afoot!

The Full Moon on February 8th or 9th, depending on your time zone, is likely to highlight both action and chaos (Moon in Leo trine Mars, and Moon trine Eris, goddess of chaos). The Full Moon chart is another instance of justice being highlighted (Sagittarius rising, with the Jupiter-Pluto conjunction applying).

The legal system appears to be in the midst of starting a major transformation as Jupiter comes in range of its first conjunction to Pluto in the sign of Capricorn since 1771. That cycle was instrumental in the development of the Declaration of Independence and the US Constitution, as it unfolded over the next 12-13 years. See page 8, column one, for more details.

There's energy for new romantic relationships to begin, and also for money to show up (Venus conjunct Chiron). Yet inflation is likely to become more noticeable now too (Jupiter sextile Neptune now in range), so you're more likely to need more money.

The Full Moon for the USA shows strong, stable, financial support for the country (Saturn and Pluto in the 2nd house trine the MC). The stock markets look energized and active in a positive direction. The bond markets look stable and strong. Something major seems to have changed!

In addition, Congress seems to be doing something to help the citizens (Venus conjunct Chiron and sextile Ceres)! Venus and Chiron are in the sign of Aries, the sign of the warrior and the pioneer. This could suggest that Congress is battling for a provision that will help the common man (sextile Ceres). We'll see what this is—at least it's a hopeful sign that Congress will accomplish something.

Love Relationships or Money?

Beginning on February 7th, a cycle associated with new relationships and money comes strongly in range (Venus conjunct Chiron). This cycle will peak on February 10th and stay in range through February 16th.

Chiron was a centaur, half horse and half human. There have been actual remains of centaurs found in Antarctica, in the ruins under the ice, so it's possible this wasn't just a myth. Chiron is associated with healing, teaching, and music in a person's chart. Chiron is also associated with a person's quest in this lifetime.

The Magi Society found that Venus-Chiron aspects were some of the strongest cycles there are for money and romantic relationships. However, Venus is weak in the sign of Aries, more of a warrior than a diplomat.

Although this cycle may not produce as much money as it would in some other signs, it's still a very helpful cycle to bring in money. Since this is a conjunction or a beginning, this cycle could be associated with the beginning of a project that will bring in money. A love relationship that develops under this cycle would likely have a lot of independence within it.

Mercury Retrograde! (Red Communications) February 16th – March 10th

Mercury stops to turn around and start moving backwards (from our perspective here on Earth) on February 16th. This time Mercury is in the sign of Pisces at 12 degrees, when it begins its retrograde motion. As it moves backwards, it has no major cycles until it meets up with the Sun on February 25th and sextiles Mars on February 26th. This suggests that someone is coming to defend the President (Sun). This may also be occurring with other leaders.

Late on February 28th, Mercury sextiles Uranus, again suggesting new ideas or new technologies being announced or re-announced, as the case may be. Then on March 4th, Mercury will sextile Venus, suggesting good communications, and money for transactions. Mercury stops moving backwards at 28 degrees Aquarius to turn around and go forward again. That occurs on March 10th.

During ALL Mercury retrogrades, there are challenges with communications, phones, emails, faxes, slow transportation or transportation breakdowns. In the winter, bad weather often challenges delivery trucks, airplanes, and cars frequently break down. This is NOT the time to sign a contract. You're supposed to be reconsidering your needs, which often turn out to be different from what you think they are.

While Mercury is in Pisces (February 3rd – March 3rd, then again March 16th – April 10th), there tends to be a lot of confusion due to vague details (or sometimes missing or no details!) You'll need to be vigilant regarding details during these periods or it will be easy to make mistakes.

Mercury in Pisces is great for being spiritually or artistically focused. It can also create compassionate communications. If your job requires the use of imagination or intuition, you're in luck! This cycle is great for both.

Mercury moves forward on March 10th, but it remains slow for another week or so. It takes until March 30th for Mercury to

move into new territory, and for us to move forward with our projects after completing all the fixes.

Visionary Ideas? Or Inflation and Higher Gasoline Prices?

Beginning late on February 2nd, and peaking on February 20th, we have a cycle associated with visionary ideas, higher inflation and higher gasoline prices. Fortunately, this cycle (Jupiter sextile Neptune) should have a more practical vision now, and less of an inflationary impact.

Jupiter in Capricorn (an earth sign) tends to have less growth associated with it. It tends to think in terms of what's doable at the moment and move forward within those parameters. The inflation tends to be less under this cycle than other Jupiter-Neptune aspects due to the slower growth.

It takes about thirteen years for an entire Jupiter-Neptune cycle. This portion of it is near the end of the current cycle, when visions for the next one are being planted now. The next Jupiter-Neptune conjunction will occur in early April 2022. Many inspirational and spiritual visions will get started then. This cycle stays in range through March 11th. We'll see this cycle again from July through November.

Breakthroughs and Bold Actions!

An interesting set of cycles occurs in the latter half of February. Beginning February 16th, the energies build up for bold actions and an important breakthrough (Mars in Capricorn trine Uranus in Taurus). This could be related to changes that need to be fixed in the financial system. Most likely this is related to leaders, including President Trump, taking an unexpected, bold action to fix a stuck issue.

These cycles (Mars trine Uranus, Sun sextile Uranus, and Sun sextile Mars) peak on February 21st, 22nd and 24th respectively. Since Mercury is retrograde at this time, the issue that's being fixed may be one that's been reviewed multiple times, but never found a resolution—until now. It's possible with Mercury retrograde that the solution may be announced, but not implemented until later in March or early April.

Mercury gets into this act too (Sun conjunct Mercury peaks Feb 25th, Mercury sextile Mars peaks Feb 26th, and then Mercury sextile Uranus peaks Feb 29th). This indicates a lot of discussion about this action and breakthrough. At the end of it, new ideas and technologies may carry the idea through to completion. That will take a bit longer though. Mercury will sextile Uranus again on March 22nd, after it moves forward.

You can use these cycles to make a bold move and have a breakthrough on a stuck issue. Look around for new ideas and new technologies to solve it. Be open to a different perspective. Often it's the way we frame a "problem" that makes the difference. What happens when you see the issue as an opportunity instead?

This particular cycle has Mars in Capricorn, a sign where Mars is strategic and organized. This indicates that our actions can be highly effective if we take strategic, focused, and organized actions. These actions are not "shoot from the hip" (that's Mars in Sagittarius). They are well planned and well implemented. Even if the actions seem unexpected, they are not impulsive. Most likely new technologies will be employed.

New Moon February 23rd: Something New is Getting Started! Space Force?

What's getting started at the New Moon on February 23rd is something NEW! This could be related to the military (Mars in Capricorn, with Jupiter, Saturn, and Pluto already there) and seems to be related to something that Trump is involved in doing. Whatever it is, it's new, different and involves unusual technologies. This could be something we haven't heard of yet. It could also be the new Space Force. (Sun and Moon sextile Mars and Uranus, Mars trine Uranus)

Whatever it is, there's a lot of money involved (Venus square Jupiter). If the Space Force is being created, then that would definitely be a pricey department. In your own budget, this cycle could indicate that you may overspend, overeat, or overdrink. (This used to be known as gluttony.) That cycle peaks on the day of the New Moon. Another one is in range that suggests a lot of debt is being created (Venus square Pluto). The latter cycle peaks on February 28th.

Fortunately, a third cycle should help reign in the spending (Venus square Saturn). That one comes in range on February 25th, and peaks on March 3rd. So as the rethinking continues, perhaps the financial picture will stabilize with less spending. This cycle can also indicate having more bills to pay than your revenue can easily handle. Save some money for this period.

There's also some chaos and some power/control issues involved with this situation (Saturn, Pluto, and Jupiter all square Eris). That might be because both the Navy and the Air Force [both have Secret Space Programs](#), and each one used different types of ETs to develop theirs.

The financial markets appear to be in a rethinking mode (Mercury retrograde). Although there may be some uncertainty, they don't seem panicked in any way. Perhaps stocks are consolidating a position?

Congress, or at least parts of it, seem very busy with the new vision, which may be the Space Force. This is more than just a new department of the military. This is a method to disclose the technologies and weapons they've had developed for many years. Space Force is a major breakthrough in many ways. They won't reveal the presence of ETs until they have an adequate means to assure the public of their safety.

March: Freedom in Governments!

March 1st greets us with an important cycle associated with power, new governments, and what's likely to be the start of reclaiming the US Constitution (Jupiter parallel Pluto, similar to a conjunction). This cycle has been in range since December 14th, 2018 and it peaked once on September 3rd, 2019. It peaks again on March 1st.

We've actually been watching this cycle in action via the many countries which have enormous protests occurring. This cycle has been paving the path for the next conjunction of Jupiter and Pluto, which will occur on April 4th. That will be the first time that cycle has peaked in the sign of Capricorn since February 24th, 1771.

These two cycles, peaking so close together, let us know that freedom within government structures is the new order of the day. The Jupiter conjunct Pluto cycle peaks three times, the last time on November 12th, just after the Election. It stays in range most of the year, February 16th through December 24th.

Within the next thirteen years (until Jupiter conjuncts Pluto in the sign of Aquarius), a great deal of progress will be made toward creating more freedom in governments around the world. The next time they meet in the sign of Aquarius, they'll continue to make further progress toward more freedom. Dictatorships will vanish.

Less Money? Followed by Unexpected Money

Beginning February 25th and peaking on March 3rd, a cycle's in range that's associated with less money and/or relationship challenges (Venus square Saturn). Often the relationship challenges are related to money!

The good news though is that unexpected money (and possibly love) is on the way (Venus conjunct Uranus). As the above cycle peaks and money may seem a bit scarce, the cycle for more money to flow in is already in range. This cycle peaks on March 8th and it stays in range through March 15th. If you stay focused on finding the unexpected money, you may not notice the potential shortage.

In addition, a third cycle (Mercury sextile Venus) makes communications a lot more pleasant and transactions a lot easier to make, even though Mercury is still retrograde. This also helps to bring in money. It's in range March 3rd – 6th and it peaks on March 4th. So look for help if you need it. It's there!

Full Moon on March 9th: A New Vision with Big Growth!

What's coming to light at the Full Moon on March 9th is a new vision for the country (Sun conjunct Neptune and the MC) that includes big growth (Moon trine Mars, Pallas Athena, Jupiter and Pluto, Sun sextile Jupiter). This new vision can also be experienced as inspirational leadership. That cycle peaks on March 8th and stays in range through March 16th.

There's also a fair amount of chaos occurring at this time (Jupiter and Pluto square Eris, the goddess of chaos), which may be the result of moving toward the new vision. Generally speaking, growth includes some amount of chaos.

In addition, there are some entrenched challenges with a potential change to the money system or currencies (Moon sesquiquadrate Venus conjunct Uranus). Whatever occurs in that arena at this time appears helpful to the US economy and growth (Venus and Uranus are sextile the USA Jupiter). However, the transition may be difficult. These challenges are also related to the new vision that's getting started (Sun and Neptune semi-square Venus and Uranus).

Mercury is coming to a stop at this time, in preparation for turning around and moving forward the next day (March 10th). So communications, travel and transportation may be more difficult than in the previous two weeks. Mercury likes to move! You may find yourself temporarily stopped or slowed in your projects or in traffic, until it gets moving again in a few days.

There's also energy available for taking fortunate actions, or at least to get them started (Mars conjunct Jupiter in range, peaking on March 20th).

The stock markets appear to be doing well (Moon trine Mars conjunct Jupiter, Mars sextile Neptune and Sun, Moon trine Pluto, Pluto conjunct Mars, Jupiter and Saturn). The bond markets may have a few minor hiccups (Sun semi-square Venus and Uranus), but for the most part, even bonds are looking good (Sun conjunct Neptune and sextile Jupiter).

Congress seems to be caught up in changes to the financial system or the currency. The entrenched issues at this time may prevent any real action on this matter, or if the financial system is dire enough, those cycles may trigger the change, even if Congress doesn't take action.

Mercury Moves Forward on March 10th

As Mercury stops to move forward on March 10th it's back at 28 degrees 16 minutes of Aquarius, picking up some new ideas for the journey ahead. It takes until March 14th for Mercury to move just one degree. So don't expect communications and transportation to speed up right away. It takes until March 24th for Mercury to start moving just one degree per day, closer to its normal speed of even faster than that.

Those dates give you an idea of when things start moving again. However, you actually have until March 29th to complete any fixes, repairs, or redo anything. After that, Mercury moves into new territory and it's off to the races again.

When Mercury moves forward, it will sextile Uranus again March 18th – 24th, getting more new ideas for the future, and solidifying ones it picked up before. This can also be a time of surprising news.

All Planets Moving Forward! March 10th – April 24th

After Mercury moves forward on March 10th, all the planets are moving in the forward direction until April 25th. That's when Pluto starts moving backwards (retrograde) from our perspective on Earth. Between these dates though, there's no resistance to moving forward with projects.

The slower, outer planets (Jupiter, Saturn, Uranus, Neptune and Pluto) move backwards about 4-5 months per year, so we have few times when all the planets are moving forward. Take advantage of this and get as much done as possible during these weeks. Also note the Pluto reaches the degree and minute where it will turn around by April 19th, so you can start encountering resistance by then, possibly a bit earlier.

Support for Leaders?

Beginning March 7th, a series of supportive cycles for leaders occur, including President Trump, but not limited to him. These cycles begin with one that promotes growth, a better legal system, and the Constitution (Sun sextile Jupiter). This cycle is in range March 7th – 14th and peaks on March 11th.

As that cycle peaks, another one comes in range. This one (Sun sextile Pluto) provides support from powerful people, organizations, and places. It's sometimes seen as the cabal or the mafia, but it also refers to large corporations, major non-governmental groups (UN, IMF, the Fed, etc) and other world leaders, particularly those who control the world from behind the scenes. This cycle is in range March 11th – 17th, and it peaks on March 14th.

During the above two cycles, a third cycle (Mars sextile Neptune) implores us to take inspired actions, instead of actions based on fear, anxiety or other negative emotions. This cycle can also be associated with lowered immune systems, or being tired. So it's more important than usual to take inspired actions, as they will increase your energy. This cycle is in range March 9th – 18th and it peaks on March 14th.

Then beginning March 16th – 22nd, a fourth cycle contributes help to leaders (Sun sextile Saturn). This is often managers who support the leader assisting in project deadlines. These cycles can also suggest different attributes of the leader, who may be seen as expansive with positive goals, powerful, and making responsible choices. This cycle peaks on March 19th, just before the Spring Equinox. Together these energies provide great support for leaders for most of the month.

Spring Equinox: Preview of Q2

In the USA, the Spring Equinox, or the first day of Spring, occurs very late on March 19th at 11:51 PM Eastern or 8:51 PM Pacific time. The chart for this event provides a preview of the next three months until the Summer Solstice on June 20th.

At this time, all the planets are still moving in the forward direction, a great set of energies for this Spring Equinox! The Sun in Aries is the strongest energy there is for new starts, and that all the planets are moving forward now is a huge support.

However, there are still five planets (Pallas Athena, Mars, Jupiter, Pluto, and Saturn), along with the South Node of the Moon and the Part of Fortune, bunched up together in the sign of Capricorn. This suggests a colder spring than usual. If you garden or farm, plan for a later spring.

From an economic point of view, these planets, and the continued emphasis on Capricorn, suggests a focus on business, governments and all types of organizations being rebuilt, reorganized, or transformed in numerous ways. There's growth, but it's slower growth based on new ways of doing business or governments. That takes time to germinate.

There's a lot of focus on values and finances in this chart (five planets, South Node and Part of Fortune all in the second house). Everyone has this mandate to consider during the next three months. How do you want to allocate your resources so they best support your values?

A great set of energies helps us with moving forward now (Venus trine Mars conjunct Jupiter). There's good energies now for taking fortunate actions and especially for new starts that include sustainability and integrity (at least through most of April). Mars conjunct Jupiter peaks just hours after the Spring Equinox occurs on March 20th.

Those energies are amplified by another cycle (Venus trine Mars and Jupiter). This suggests that you know what you want, *and* you know how to get what you want. Notice that there's a major emphasis on the steps you take being practical (Venus, Mars and Jupiter are in earth signs). Mars in Capricorn is exalted, because this warrior takes strategic and organized actions that yield great results. Follow his lead!

With Venus in Taurus (in rulership and strong), there's likely to be money and supportive relationships for your projects. This is one of those rare times when the energies are lined up in a great way! Take advantage of this. **Notice that March 26th -- 28th are exceptional dates for new starts. Plan now to use them!**

What's the challenge with the coming quarter? There are two of them. One is that there's resistance to making changes (Saturn square Uranus). This might be resistance to new technologies, or it might be resistance to changing processes, structures, the way you make money, or with whom you work. This cycle won't peak until 2021, but the challenge is beginning to form now. It's stronger March 21st – June 30th, then retreats.

The second challenge is related to values, money or relationships and how you *feel* about them (Moon square Venus). If you've been taught that money is filthy and only poor people are good, you might not feel comfortable having enough money to pursue your projects and goals. A different perspective is to understand that it takes money to develop yourself and your skills to the highest level possible, so you can contribute to humanity at your highest level.

At this Spring Equinox, we also have new ideas, new technologies, and/or surprising news being revealed (Mercury sextile Uranus). This suggests that one of the ways you'll accomplish your projects is via some new ideas or new technologies. This cycle is in range March 18th – 25th. It peaks on March 22nd. The patents for the US Navy Star-Trek technologies have been revealed. Stay alert for more options!

In addition, there are plenty of healing energies afoot (Sun conjunct Chiron, Mars, Jupiter and Pluto all quintile Chiron, Moon septile Chiron). So look for new options to heal in the coming months. Maybe Med Beds will be revealed?

Plus money for donations and forgiveness are also in these Spring Equinox energies (Venus in Taurus sextile Neptune in Pisces, both in rulership). If you have a humanitarian project, look for the funding at this time. It's available. This cycle peaks on March 22nd and it's in range March 19th – 25th.

Saturn into Aquarius on March 21st

Very late on March 21st (11:58 PM Eastern / 8:58 PM Pacific), Saturn tiptoes into the sign of Aquarius for a few months. This

is the time to notice what new types of structures and processes are heading our way. It will stay in Aquarius through June 30th and then move back into Capricorn until mid-December 2020. Then it will be in Aquarius for over two years. See the article on page 9 for details of this major change.

New Moon on March 24th: Transformed Motivations? New Funding?

What's getting started at the New Moon on March 24th appears to be new funding sources, possibly large international companies or organizations, which are looking to fund new programs (Jupiter, Pluto and Mars conjunct in Capricorn, all trine Venus in Taurus, plus Sun and Moon quintile both Jupiter and Pluto). A lot of what's happening is behind the scenes at the time of the New Moon. It's not yet ready to be announced (Mars and Pluto in the 12th house).

In addition, what's getting started is related to transforming motivations (Mars conjunct Pluto). This cycle peaked the day before on March 23rd and it's associated with powerful people or organizations taking actions. However the actions may be ones that wouldn't have occurred prior to this cycle, due to a change in their motivations. This cycle is in range March 12th – April 3rd. You may have already seen some results of this.

Saturn moved into the sign of Aquarius a few days before this, setting up an official challenge to making changes, especially financial system or currency changes (Saturn square Uranus in Taurus). This might show up as challenges to Bitcoin or other types of cryptocurrencies, but at this point it's minor. This issue won't become a big deal until late January 2021. It's giving us a warning now.

The above cycle could also be a heads-up about the US dollar if it hasn't already become US Treasury Notes backed by gold or other metals. Hopefully this will have already occurred before this New Moon. If not, the US dollar could easily change to US Treasury Notes on March 27th or 28th.

This New Moon also embodies energies for healing and teaching (Sun and Moon closely conjunct Chiron and all of them trine the MC). Just as the Spring Equinox suggested, new methods and/or technologies for healing could be released at this time. Watch for this in the next three weeks.

One other major cycle is occurring at the New Moon (Sun and Moon closely square the Nodes of the Moon). This can suggest that leaders and the public are pulling the country off-track from where it should be headed at this time. It's possible this is related to impeachment hearings taking place in the Senate. This seems very late for that to be occurring. Perhaps it will be another big issue between Congress and Trump.

BIG Money and a LOT of It!

Beginning March 21st, three major cycles are in range at the same time, suggesting a LOT of BIG money is being disbursed (Venus trine Mars, Jupiter and Pluto)! From the looks of this, a lot of fortunate new starts are about to get funded. Could this be the release of the long-awaited humanitarian funds? If they've already been released by this point in time, then it's something else, and still very BIG.

Late on March 27th and early on March 28th, the Moon in Taurus also gets into the act. This Moon is exalted – very strong in its best sign. It reinforces this incredible big funding that's occurring, adding something to it (Moon conjunct Venus, Moon trine Jupiter, Mars and Pluto). Plus Venus in Taurus is in her sign of rulership—she's strong too!

This funding is part of an even bigger set of cycles occurring at the same time. Jupiter conjunct Pluto in Capricorn will peak on April 4th for the first time since February 1771. This cycle could herald the beginning of the renewal or reclamation of the US Republic. With that in mind, it's completely possible that this is the time when the US dollar will become US Treasury Notes and the US will no longer rent its money, which kept it in debt.

On March 27th another cycle is in range (Mars square Uranus), which suggests that breakthroughs are occurring. This cycle gets stronger on March 30th and it takes until April 7th to peak. An energy of this type is needed to ensure a breakthrough could occur and the US dollar could become US Treasury Notes backed by metal. It's also needed to help reclaim the Republic. It stays in range through April 18th.

Another cycle also suggests this is a time to do financial planning (Venus trine Saturn) and/or taxes. This cycle comes in range on March 27th and peaks on April 4th. Combined with the cycle below, financial planning is very important now. This cycle stays in range through April 13th.

On March 30th, Mars moves into Aquarius and immediately meets up with Saturn on March 31st. This is our heads up that it's time to make a new plan. This plan should include some new ideas, perhaps new technologies or new inventions. The Universe would prefer that you have a written plan, not just a fuzzy idea in your head. Who is going to do what by when? What's the main goal? Who will assist you?

If you're planning humanitarian or other projects, then it's likely you'll get your funding by the end of March, if not sooner. This will be the time to get a solid plan together, once you know the amount of funding you'll have. Be sure to make use of this cycle. It stays in range through April 11th.

A VERY Cold Winter!

This winter there are an exceptionally large number of planets, asteroids, and important points in the signs of Capricorn and Aquarius. Both of these signs are COLD! With three slow, planets (Jupiter, Saturn and Pluto) in Capricorn for the winter, and other faster planets coming in to join them throughout the winter, this is likely to be a humdinger of a winter. Even at the Spring Equinox, we see this major line-up of planets in Capricorn, suggesting a cold spring.

Even if you live in the south or southwest, you're likely to experience more cold than usual, plus possibly ice and snow. [Kryon told us in June 2017](#) that the Earth would begin a mini-ice-age **within 15 years**. Now we're within 12.5 years of it starting. Use this winter as a chance to prepare yourself for what's ahead.

Reader's Corner: Questions and Stories From You!

Q. Where are cryptocurrencies going in 2020 and beyond?

A. As I've been writing about for the past year, now that Uranus is in Taurus to stay until April 25th, 2026, this combination actually represents digital or electronic currency. Cryptocurrencies embody this energy and they will continue to increase during the coming 6+ years.

Here's an [interesting video](#) about the current economic situation. It covers some disturbing (but not surprising) news regarding the gold in Fort Knox. Near the end of it, at about the 28 minute mark, Ron Kirby starts talking about a proposed alternative to the US dollar as the reserve currency, which is proposed as a digital currency. He then expounds further on cryptocurrencies.

Although the cycle of Uranus in Taurus supports cryptocurrencies, keep in mind that each cryptocurrency will have a different demand for it. Some will do better than others. Look for asset-backed cryptocurrencies.

Q. What are your thoughts on the 2020 Election? Will it be Trump 2020?

A. At this point in time, without a Democratic nominee, my answer to this question is based on the energies for the day of the Election, November 3, 2020. The day of the Election shows that the big issues are related to the economy, the reclamation of the Republic, justice instead of a two-tier legal system, and transforming structures that are out of integrity.

Trump is the only candidate who has any focus on reclaiming the Constitution and ending the two-tier legal system (drain the swamp). This could change, and other candidates could jump on this as the process continues. If other candidates *don't* do that, then Trump would be the only contender in this race.

In addition, the chart for Election Day shows that the President to be elected is someone unusual, even radical. This won't be an establishment politician. Bernie Sanders could fit this bill, if he's the Democratic nominee. Trump definitely fits that description, so he's in the running on that one too.

Election Day is the last day of Mercury retrograde. This is likely to indicate either recounts, and not knowing who wins that night, and/or that Trump is RE-elected. This day also has a very strong cycle for election fraud (Moon square Neptune). So recounts may be necessary in order to discover who the actual winner of the Election is.

Mars is also retrograde in the sign of Aries, suggesting that voters are angry. That can be spun a number of ways. At the moment, there's anger that the Democrats didn't follow due process in their impeachment process and impeached Trump even though there was no evidence of wrong-doing. We'll see what voters are angry about next year. If it's the attempted (bloodless) coup, then Trump will win.

Lastly, this is just an observation. If you watch any of the Trump rallies on YouTube, you'll see that he gets 40,000 to 50,000 people at his rallies (20,000 – 25,000 people inside and a similar number outside) no matter where they are held. Just observe how many people consistently show up at the Democrat nominee's rallies. That will give you a big clue to the winner of the Election.

Q. Is there any relief in sight for weather warfare, including chemtrails, and the energies supporting its exposure and the arrest of the perpetrators?

A. The astrological answer to this question is we don't have good data on what represents chemical and weather warfare using the planets. At this point, an astrological answer would be speculation.

However, there is plenty of data on arrests and we have the ultimate "arrest configuration" in 2020 (Saturn conjunct Pluto in Capricorn). This suggests we should see arrests shortly after the beginning of the year. The January 10th Lunar Eclipse has a primary meaning related to sudden loss of associations or relationships. Perhaps some of the losses are due to arrests?

In addition, [David Wilcock has put out some information](#) about chemtrails and where the chemicals and tools were based at the base in China Lake CA. That base was made inoperable in early July 2019 via two precisely directed earthquakes. It looks

Q. When will the next big recession hit?

A. The answer to this question depends in large part on the actions we're waiting for from the US government, the International Monetary Fund, the Bank of International Settlements, and China. If we have a RESET of the financial system, then that would completely change the timing of when a recession would hit.

WITHOUT the reset then, when the North Node is in Aquarius, the US is at the bottom of its economy. In early May, the North Node will move into Gemini. The economy will start to lessen its growth as this occurs, but not actually go into a recession. It will take until late July 2026 for the North Node to get into Aquarius, and the economy will gradually drop as it gets there. It will be there for 18 months, through 2027.

Will the country go through a reset though? It has no choice but to do so. Once the Saturn-Pluto conjunction occurs in January 2020, this becomes more likely, as the rebuilding process begins. A reset would eliminate sovereign debts, create a new currency backed by metal, and make all currencies asset-backed. Most likely the reset would also include a new financial system, instead of what we have.

All these changes would reset the economy and new cycles would begin. We'd need to observe them for quite a few years to see the new pattern. My best SWAG is that the reset will occur within the first quarter of 2020.

Q. What astrological energies are supporting us in handling the negative news we will be hearing in 2020 as we cleanse our sacred planet Earth of the actions we collectively have agreed can no longer be tolerated—i.e. human trafficking and other related crimes against humanity?

A. First, I want to suggest that you reframe this question. Plenty of people will view the news of the arrests of people who have committed these crimes as positive, even though they may be surprised who gets arrested. Those who have not prepared themselves for these events will have some emotional traumas to process. Yet they made the choice to experience that shock by ignoring the evidence of these crimes for multiple years.

The Winter Solstice had the Sun, Mercury, Ceres (goddess of nurturing), Saturn, and Pluto all tightly together in Capricorn. The answer to your question lies in that chart. Ceres, the

goddess of nurturing, is there to help cushion the blow and nurse wounded spirits back to health.

Saturn and Pluto are there to make the arrests. (Just the facts ma'am!) They remind us that although perhaps we'd rather not know about this situation, we *need to know* about it and confront it, so it can be cleaned up. It was the unwillingness to see what was happening that allowed it to continue for so long.

Jupiter will also sextile Neptune this year, helping us to see a new vision for our future. This cycle is in range for quite a bit of the year. Plus 2020 has Venus and Mars retrograde, when we can rethink our values, our motivations, and how we want to spend the next two years to support our values. Perhaps one value that will receive more support is to be willing to see what's happening and respond to it.

Everything that happens in the world is occurring on *your watch*. Each and every one of us is responsible for paying attention to what's happening around us and alerting others to it. This is the lesson of Saturn conjunct Pluto in Capricorn. You must pay attention to what's happening so you can direct the rebuilding of the new system to be one that you want. If you release this responsibility to others, you get what they want. Take back your power by accepting responsibility for it.

Q. Kryon is fond of saying, "You don't know what you don't know." What planets are supporting us in business in catching these waves of changing times, such that we become aware of what we don't know in time to create abundance from this new knowing?

A. To a great extent, the answer to your question is that you must set your intention for this to occur. Talk to the Universe regularly and remind It of this intention.

In terms of the cycles, Saturn conjunct Pluto in Capricorn can transform our sense of time and how we use it. It also demands that we create new structures to replace the ones that aren't sustainable and in integrity. You cannot grow in 2020, business-wise or personally, without accepting responsibility for whatever shows up in your life.

Saturn, Pluto, and Jupiter together in Capricorn suggest that growth comes from a greater level of awareness and accepting more responsibility. Slow, steady growth is the order of the year! New structures are needed before you can grow. You'll learn what you need to know with each step.
